\*\*CC Real Estate Income Master Fund (CCREI) is a master fund in a master/feeder structure, which pools investor capital raised through its feeder funds, such as the current fund offering described in this fact sheet, CCREI Fund (the Fund). The Fund invests substantially all of its assets in CCREI. Investors in the Fund are purchasing shares of a feeder fund, not CCREI. The investment results of the Fund are directly dependent on the investment results of CCREI, which seeks to execute the investment strategies described in the Fund's prospectus.

The Board may, in its sole discretion, determine to limit the number of shares to be repurchased to an amount that is greater than or less than the amounts described above. Additionally, the Fund will further limit the number of shares to be repurchased in any calendar quarter to 5.0% of the weighted average number of shares outstanding in the previous full calendar quarter prior to the date upon which the notification to repurchase shares was provided to shareholders of the Fund. The Fund will limit the number of shares to be repurchased in any calendar year to 20.0% of the weighted average number of shares outstanding in the prior calendar year. The Fund intends to offer to repurchase shares at a price equal to the NAV per share on each date of repurchase. 3) The sponsor commitment represents the aggregate investments in CCREI made by affiliates of Colony Capital as of June 30, 2018. 4) Pursuant to separate expense support and conditional reimbursement agreements between an affiliate of Colony Capital, Colony Capital FV Holdings, LLC ("Colony Capital FV"), and each of CCREI and the Fund, Colony Capital FV will reimburse CCREI and the Fund for certain expenses to seek to ensure that each of CCREI and the Fund bears a reasonable level of expenses. ## RISK FACTORS

An investment in the Fund involves a high degree of risk and may be considered speculative as well as illiquid and a prospective investor should invest only if they can sustain a complete loss of their investment. The following are some of the risks involved in an investment in the Fund; however, investors should carefully consider all of the risks discussed in the Fund's prospectus before deciding to invest in the Fund.

- The Fund intends to implement a share repurchase program, but only a limited number of the Fund's shares may be eligible for repurchase. The repurchase program may be terminated at any time. Accordingly, you should consider that you may not have access to the money you invest for an indefinite period of time until the Fund completes a liquidity event. There can be no assurance that there will be a liquidity event at all.
- Because you may be unable to sell your shares, you may be unable to reduce your exposure to the Fund in any market downturn.
- As a closed-end fund, the Fund does not redeem its shares on a daily basis. Unlike most closed-end funds, the Fund's shares are not listed on a securities exchange and it is not anticipated that a secondary market will develop. As a result, shareholders should not expect to be able to sell their shares regardless of how the Fund performs.
- The shares of the Fund sold in this offering will not be listed on an exchange and the Fund is not expected to consider alternatives for providing liquidity to the shareholders for at least five years from the completion of the offering stage, and there can be no assurance that there will be a liquidity event at all. Therefore, if shareholders purchase shares of the Fund in this offering, they will have limited liquidity and may not receive a full return of their invested capital if they sell their shares.
- The Fund expects that some of its distributions may be paid from sources other than cash flow from operations, such as offering proceeds, borrowings or sales of assets, which may reduce an investor's overall return and may constitute a return of capital. You should understand that any such distributions would not be based on the investment performance of the Fund and would be sustained only if CCREI achieves positive investment performance in future periods.
- This is a "best efforts" offering, and if the Fund is unable to raise substantial funds, CCREI will be limited in the number and type of investments it may make, and the value of a shareholder's investment may be reduced in the event CCREI's assets under-perform. S2K Financial LLC has only limited experience selling common shares on behalf of a registered closed-end management investment company and may be unable to sell a sufficient number of shares in the Fund for the Fund and CCREI to achieve their investment objectives.
- Investors will incur immediate dilution as a result of any selling commissions and dealer manager fees paid by the investor and offering expenses the Fund will incur.
- CCREI and the Fund are recently organized companies and have limited operating history.
- CCREI may make investments that may be rated below investment grade by rating agencies or that would be rated below investment grade if they were rated. Below investment grade securities, which are often referred to as "high yield" securities or "junk bonds," may have speculative characteristics with respect to the issuer's capacity to pay interest and repay principal. - CCREI intends to invest a substantial portion of the proceeds from this offering in a portfolio of CRE securities, debt and equity investments. The collateral securing the Fund's CRE debt securities, as well as the equity investments, may decrease in value or lose all value over time, which may lead to a loss of some or all of the principal in the debt and securities investments CCREI makes.
- Because real estate investments are relatively illiquid, CCREI may not be able to vary its portfolio in response to changes in economic and other conditions and may be unable to dispose of certain assets at a fair price, resulting in losses to CCREI.
- CCREI may use leverage in connection with its investments, which may increase the risk of loss associated with its investments. In addition, if a wholly owned special purpose vehicle of CCREI's REIT subsidiary (the "REIT Subsidiary") is unable to pay principal and interest on borrowings it has incurred, a default could result in foreclosure of any security instrument securing the debt and a complete loss of the investment, which could result in losses to the REIT Subsidiary and, therefore, to CCREI and the Fund.
